Greetings!

We are pleased to announce the upcoming Inter-House English Debate Competition (**Rhetoric Realm**), designed to enhance the critical thinking and public speaking skills of our students. The competition will be held on **September 3, 2025**, and we invite all houses to participate in this exciting event. Kindly find the following structure of the debate:

### Categories

1. Classes VI to VIII
2. Classes IX to XII

### Number of Participants

#### 1. Category 1: Classes VI to VIII

- Team Composition: Each house can send one team comprising three students:
- One participant will speak in favor of the topic.
- One participant will speak against the topic.
- One participant will handle the rebuttal.

#### 2. Category 2: Classes IX to XII

- Team Composition: Each house can send one team comprising two students who will participate in the turncoat debate. Both of these participants should choose different topics from the recommended list of topics.

### Topics

#### • Category 1: Classes VI to VIII

- Should government jobs have no reservation system?

#### • Category 2: Classes IX to XII

- Is India's economic growth benefitting only the rich?
- Is India ready for One Nation, One Election?
- Parenting education should be mandatory
- Is India's membership in BRICS more important than ties with the USA?
- Should India prioritize space missions (like Chandrayaan & Gaganyaan) over poverty eradication?

### Note:

**Category 1:** There is only one topic.

**Category 2:** There are five topics, out of which each speaker needs to present on any one individually.

## General Rules And Guidelines

### Eligibility:

- Open to students from Classes VI to XII.
- Each house can send one team per category.

### Team Composition:

- Category 1: Three students (one for the motion, one against, one for rebuttal).
- Category 2: Two students participating in Turncoat debate.

### Debate Format:

- **Category 1 (Classes VI to VIII):**
  - Speaker 1 (For the Motion): 3 minutes
  - Speaker 2 (Against the Motion): 3 minutes
  - Rebuttal Speaker: 1 minute 30 seconds
  - 30 Seconds for the rebuttal to frame and ask question. (Only 1 question)
  - 1 minute for the speaker to answer the question put forward by the rebuttal.
- **Category 2 (Classes IX to XII):**
  - Turncoat debate: Each speaker will switch sides (for and against the motion) as per the chair's instructions.
  - Speaker 1: 3 minutes
  - Speaker 2: 3 minutes

### Preparation Time:

- Category 1 & 2: No additional preparation time.

### Judging Criteria:

- Content and Argumentation
- Delivery and Clarity
- Rebuttal and Responsiveness
- Adherence to the Topic and Rules
- Body language

**Use of Gadgets:** Use of any electronic devices is not allowed.

### Prizes and Awards

Certificates will be given to FIRST, SECOND and THIRD, in each category.
