Brief Note About the Activity:

1. **Enactment of short Act:** Students participated in a situational act in which various roles were played by all 4 students topics such as "Why to prefer drafting a deed"

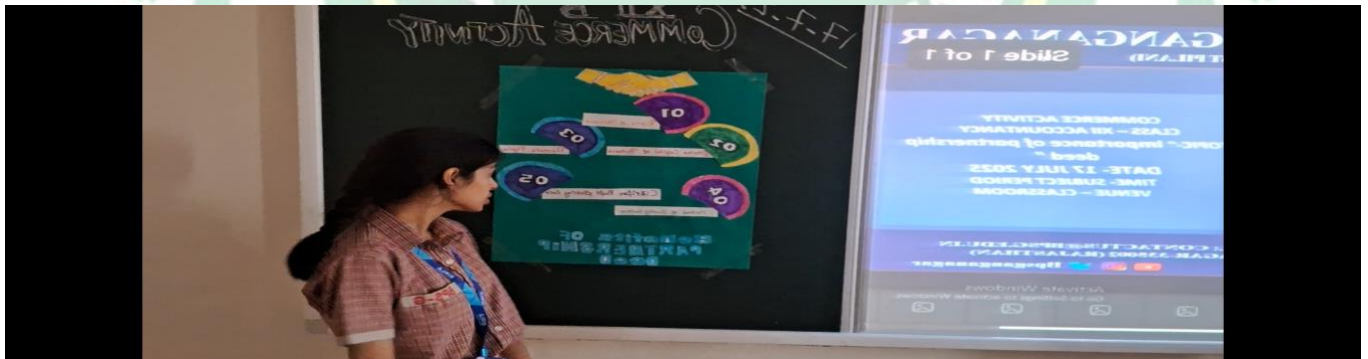
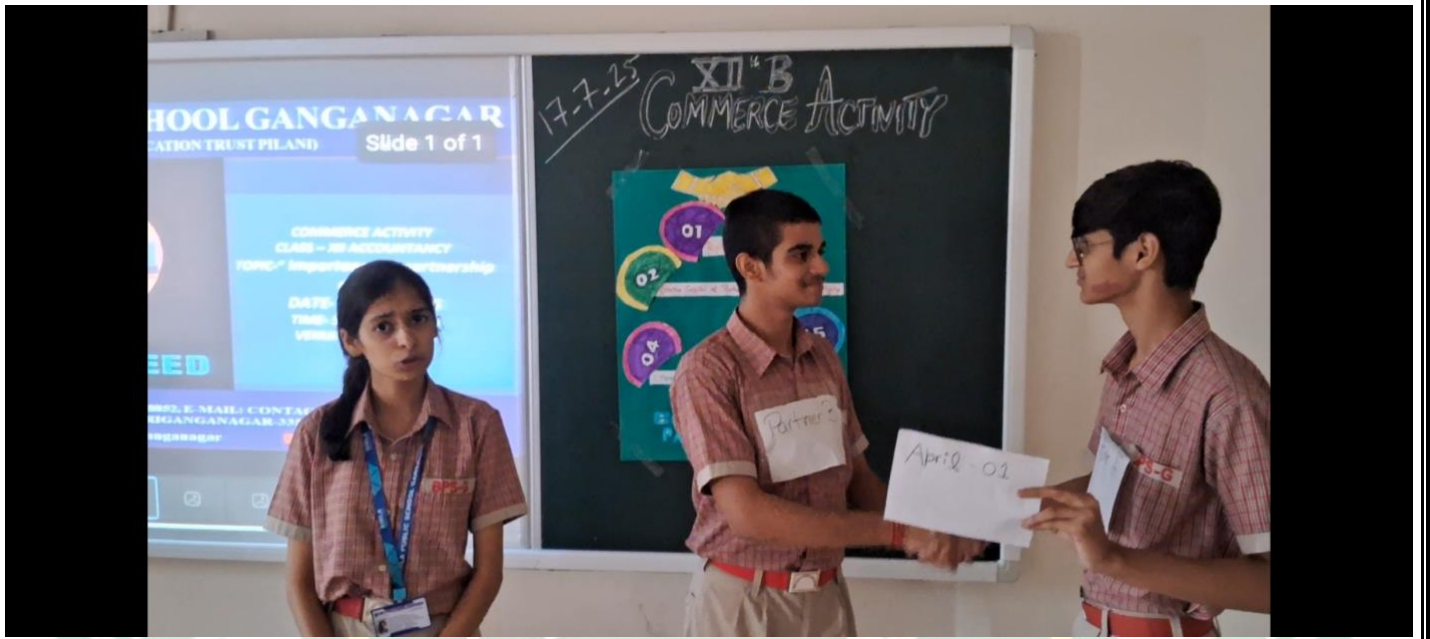
